# Off-Campus Lunch Pass Policy

*PLEASE READ CAREFULLY*

The governing board of the Bonita Unified School District, pursuant to section 44808.5 of the Education Code, has decided to permit qualified pupils enrolled at Bonita High School to leave the school grounds during the lunch period. **The Off Campus Lunch Pass is considered a privilege and can be revoked at any time due to academic, attendance, or behavioral issues.** Section 44808.5 of the Education Code further states: "Neither the school district, nor any of its officers or employees thereof shall be liable for the conduct nor safety of any pupil during such time as the pupil has left the school grounds pursuant to this section."

### Off Campus Lunch Policy

1. Only eligible juniors and seniors will be issued an off-campus sticker only upon the receipt of a completed and signed authorization form.
2. Issuance of lunch pass is dependent upon maintaining a 2.0 or higher GPA, evaluated each quarter, as well as good behavior, and positive attendance.
3. Students exercising this privilege should exit for lunch through the main parking lot gate, or the gate by the front office. Students will be checked at the assigned exit by a campus supervisor and must have a valid ID card in hand. ID cards may be physical or through the Mingo app. (Pictures of an ID card will ***not*** be accepted)
4. **Students are expected to show their ID card with the off-campus lunch sticker when requested.** If the student has forgotten their lunch pass they may request an emergency pass by filling out the google form (<https://forms.gle/NLaMcdmYAwrKEyUW8>) and seeing Ms. Hurley in the office (1 per semester).
5. Students will drive vehicles in a responsible manner and will be held accountable for accidents or damages resulting from the use of such vehicles.
6. If a student does not return to school at all, the student (if 18 years of age) or the parent must call the school that **same day, prior to 4:00 PM**. Failure to do so will result in a truancy and a potential Saturday School.
7. Students may lose their "Off Campus" privilege for the following reasons:
  - Disrespect to school staff.
  - Passing a card to another student.
  - Visiting other schools or interfering in any way with community activities.

- Failing to return punctually and regularly from lunch to 6th period class.
- Failure to serve Saturday school
- Issuance of a Suspension

**8. Requirements will be re-evaluated at the end of each quarter.** Students that do not meet the academic, attendance and behavioral requirements will have the privilege revoked for the following quarter. Students who lose their off campus privilege may re-apply at the beginning of any quarter.
